I have been making enquiries on the issue of both the landscape and heritage studies. These will be very relevant to Thaxted. I've been told that a paper will be coming to the Local Plan Leadership Group probably in April so we need to watch that one. There is a meeting tomorrow and I gather the main paper will be on culture and the arts. There is also a paper on the classification of settlements. I imagine that officers have already decided this and members won't get much of a say. Thaxted is likely to be in some sort of Local Rural Centre category along with places like Takeley and Newport.

To resolve that under the Public Bodies (Administration to Meetings) Act 1960 (as extended by s.100 of the Local Government Act 1972), the Public and accredited representatives of newspapers be excluded from the meeting for the following items of business on the grounds that it involves the likely disclosure of exempt information as defined in Part 1 of Schedule 12A of the Local Government act 1972.

21/22.978 CLT Mediation

Cllr Flint discussed the matter with some history in connection to a piece of land located at the Bardfield Road site adjoining Levitts farmhouse. At the last CLT meeting it was decided that a full board meeting would conclude that the RCCE would recommend that the CLT seek mediation in connection to a matter not related to the Parish Council, we understand that this has now been declined by one of the parties, however in the interests of inclusion the Parish Council have been asked to review the documentation in which they are named and comment accordingly. The Parish Council understand the matter in question to be in relation to a NON declaration of a pecuniary interests from a board member of the CLT who's land adjoins ours. The clerk reiterated that should this matter be directly related to a Parish Councillor, the rules as laid out in the Councillors code of conduct are very clear and stipulate that, a Breach of the requirements related to disclosure of pecuniary interests (DPIs) may amount to a criminal offence.

RESOLVED To **RESPOND** that the Parish Council have the right to communicate with developers under the development policy adopted by the Parish Council in August 2018. The boundary of the land in questions remains in dispute with the adjoining neighbour who we are aware is currently a CLT Board member, Not a Parish Councillor. The Parish Council or members of the Parish Council who may jointly sit on the CLT Board need make no Declaration of Pecuniary interests in matters relating to this plot, as there is none to make. The Parish Council thank the Board secretary and the Board of The CLT for bringing these matters to our full attention for official comment, however the Parish Council are not able to conclude past their own involvement in matters relating solely to the CLT.
