



# Accessibility statement for Thaxted.co.uk

This website is run by Thaxted Parish Council. We want as many people as possible to be able to use this website. For example, that means you should be able to:

- change colours, contrast levels and fonts
- navigate most of the website using speech recognition software
- listen to most of the website using a screen reader (including the most recent versions of JAWS, NVDA and VoiceOver)

We've also made the website text/font as simple as possible to understand and read. AbilityNet has advice on making your device easier to use if you have a disability.

## How accessible this website is:

We know some parts of this website are not fully accessible:

- you cannot modify the line height or spacing of text
- some older PDF documents are not fully accessible to screen reader software
- you may find you cannot skip to the main content when using a screen reader
- there's a limit to how far you can magnify the map on our 'Location' page

This website is partially compliant with the Web Content Accessibility Guidelines version 2.1 AA standard, due to the non-compliances listed below.

### **Non accessible content**

The content listed below is non-accessible for the following reasons.

Non compliance with the accessibility regulations:

Some content when viewed on a mobile device does not always display properly, so people using a screen reader cannot always access the information. This fails WCAG 2.1 success criterion 1.1.1.

### **Disproportionate burden**

Navigation and accessing information:

It is not possible to ensure the site is always accessible by all known and future screen reader technologies but we do endeavour to resolve issues to the best of our capabilities if made known to the council and resources allow.

### **Interactive tools and transactions**

We've assessed the cost of fixing the issues with navigation and accessing information, and with interactive tools and transactions. We believe that doing so now would be a disproportionate burden within the meaning of the accessibility regulations. We will make another assessment when the supplier updates their product, current timing unknown.

### **Content that's not within the scope of the accessibility regulations**

PDFs and other documents:

Many of our older PDFs and Word documents do not meet accessibility standards – for example, they may not be structured so they're accessible to a screen reader. This does not meet WCAG 2.1 success criterion 4.1.2. Some of our PDFs and Word documents are necessary to providing our services. For example, we have PDFs with historical information.

The accessibility regulations do not require us to fix PDFs or other documents published before 23 September 2018 if they're not essential to providing our services. For example, we do not plan to fix historical Agenda, Minutes or Finance related documents that are not accessible under the WCAG standards. The intention is for any new PDFs or Word documents we publish will meet accessibility standards.

### **How we tested this website**
